Sanction of the Governor of Punjab was accorded for taking over of National College for Women, Machiwara, Tehsil Samrala, District Ludhiana by Government of Punjab Department of Higher Education (Education-1) vide Notification No. 12/3/2018-3Edu1/2058 dated 29.09.2021 in public interest. This sanction is subject to the following terms and conditions: -

- 1 The Managing Committee of the College shall transfer the endowment fund at present pledged to the concerned University to the Government in the name of the Director of Public Instruction(C), Punjab
- 2 The Managing Committee concerned shall transfer to the Government its all the movable property, immovable property, funds and other assets attached with the college or standing in the name of the Management.
- 3 The amalgamated fund and other college funds shall be transferred in the name of the Principal of the College to be appointed by Government. Any advance drawn on loans basis from the college Pupil's fund will have to be recouped by the Management within three months from date of notification
- 4 The Management will ensure that the staff engaged in the college has been fully paid their salaries and other dues before the college is taken over by the Govt. Any arrears due to the staff as on the date of taking over will be pure liability of the Management.
- 5 The Government shall not be responsible for any liability for the period prior to the taking over of the college. All such liabilities shall lie with Managing Committee and the same shall be responsible to clear it within three months from date of the notification.
- 6 Confirmed and regular staff (Justified on the basis of actual workload in accordance with the prescribed norms for different categories of staff), appointed through proper channels and approved by the University/Department will be initially taken on adhoc basis subject to the approval of the Punjab Public Service Commission wherever applicable.
7. Only such members as described in para 6 if found suitable by the Punjab Public Service Commission/Subordinate Service Selection Board Department Committee, shall be taken over in the Govt. Service and regularized as new entrants in the services. They shall be placed at the tale end of the existing seniority lists in their respective cadres. The Principal appointed by the management, if possessing the requisite qualifications will be taken over as a lecturer in its respective subject and shall be placed at position one amongst the Lecturers of this taken over college. The Government pay scales in respect of respective categories shall be admissible to them and there shall be no personal grade/pay for any one.
- 8 . While taking over this college only graduation and post graduation (if any) classes will be taken over. 10+1 and 10+2 classes will be discontinued as per policy of the government of having no school level classes in the colleges.
- 9 All the subject posts approved & sanctioned by Affiliating University will be taken over, but only 11 teachers including Principal (List attached as Annexure A) will be considered and taken over as senior most teacher working presently and who fulfill the requisite UGC qualifications will be taken over, subject to re-verification of their qualifications and documents.
- 10 The Teaching and Non-Teaching staff that does not fulfill the eligibility conditions of UGC/University/Punjab Government and whose selection has not been made as per standard procedure in a transparent way will be deemed to be relieved from the date of notification about taking over of the college. No financial burden prior to taking over such employees will be borne by the State Government. It will be sole responsibility of the Management to settle any such claims
11. For other Administrative and Financial matters, not specifically mentioned in the foregoing paras the College shall be governed by such rules regulations/instructions and orders as issued by the Government of Panjab from time to time and as may be applicable to other Govt. Colleges in the State of Punjab

12 The Managing committee concerned shall execute a gift deed for the transfer of all the assets of the college to Government immediately and the same shall be executed by the Director of Public Instruction (Colleges) Punjab on behalf of the State of Punjab in the form prescribed for the purpose within one month from date of notification.

13 The Management will have to satisfy the Department about the proper utilization of all grants given by the Department of Higher Education/U.G.C./ any other source up to the date of taking over. The responsibility of setting all audit objections, disputes etc. prior to the date of taking over will be that of the Management Committee. The proper utilization certificate duly audited and signed by the Chartered Accountant will be provided by the Management within three months from date of notification.

14 The employees who would be taken over shall not be entitled to count their service rendered under the private management for the purpose of gratuity, pension, leave encashment etc. and would be governed by rules of the Govt. of Punjab in force at time of notification.

15 Director Public Instruction (Colleges) shall obtain an undertaking from all the employees including Principal being absorbed in Government services as per conditions laid down in foregoing paras. that all these conditions are acceptable to them. In the event of an undertaking not being given by the Principal or any of the members of the staff, the Government shall not be responsible to adjust them in the Service.

16 The Government may also impose any other condition, as it may deem appropriate, for taking over of the College.


