The person to be appointed as a Vice-Chancellor should be a distinguished academician, with a minimum of ten years' of experience as Professor in a University or ten years' of experience in a reputed research and /or academic administrative organization with proof of having demonstrated academic leadership.
- The age of the applicant should not be more than 67 years as on the closing date of receipt of application.
- The appointment shall be for a period of three years.

Procedure for appointment

- The appointment will be made from a panel of names recommended by the Search-Cum-Selection Committee.
- Reputed academicians may also nominate the name of the candidates for the post of Vice-Chancellor.
- The search-cum-selection committee may consider the name of any academician who may not have even applied and who fulfills the requisite qualifications for the post of Vice Chancellor..
